The Curacao E-zone

(why you should pay no more than 2% corporate tax ...)

+ 2% corporate tax...

First: about the way we work.

We at HoverSmeight have a rule; if we handle a service, it must be done in the most efficient way. We don't like bothering you to much with all the details.

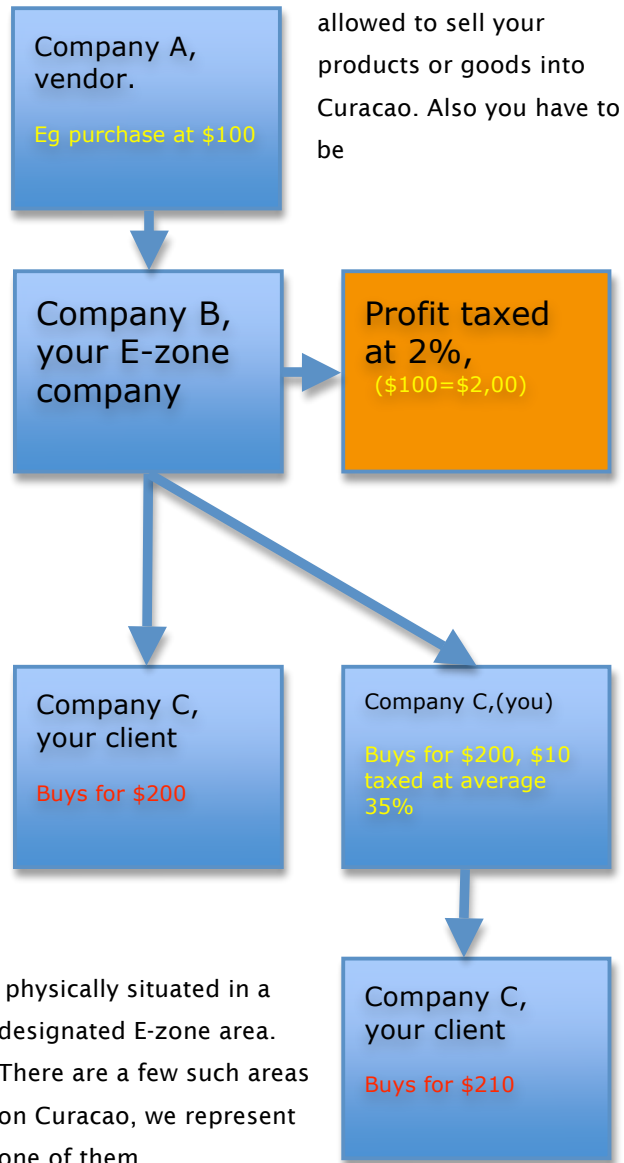
However there are things you will have to do; we can't live without. But remember, we try to limit your time to the absolute minimum so you can do what you're good at; being a successful entrepreneur.

The Curacao E-zone.

Although there is a lot what one could say about the Curacao E-zone, paying only 2% corporate tax is a lot better than most countries charge. Although there are places in the world where you pay 0% tax, paying a bit more can be helpful. Some tax treaties (with e.g. the Netherlands, Norway, Spain) will not charge taxes again if you already paid taxes. So 2% is the fee to pay....

What are the rules?

There are some rules where you have to comply with. First of all, the E-zone is a place where services or goods go by; not physically stocked. Its an ABC, where the goods or services are bought in A by B (the E-zone company) and sold in C. Or the goods are "made" in B and sold in C. These are services rendered in the E-zone. Furthermore no financial services, property rights or patents are feasible in the E-zone neither (than for a small part) are you



We won't deal with sex-gaming or casino related companies. In our represented E-zone there are NO such companies allowed!

In that area you will have to have "substance", meaning you to have office or at least a server (if you have an E-commerce company) in the E-zone. A P.O. box company won't do....



Its not complicated, it's just some rules.

Lets keep it simple; we will arrange the whole setup after we checked whether you will comply with the rules.

This means:

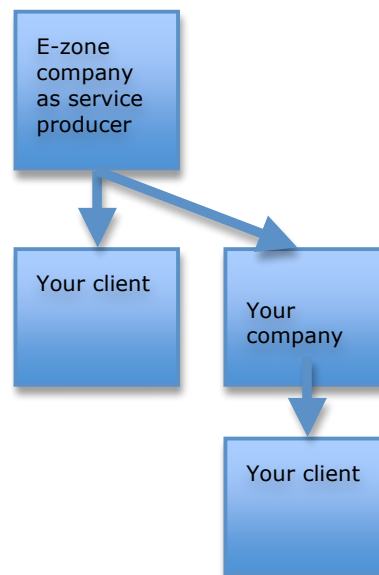
- Setting up a E-zone offshore company
- Provide the local director
- Arrange a office or server lease agreement in the E-zone
- Apply for the license
- Apply for the offshore bank account

All in one go: setup US\$ 1098,00 + yearly US\$ 1500 for the local director. Depending on the office or server needed, from US\$ 250,00 per month. Application for bank account and E-zone license are included.

Even less complicated

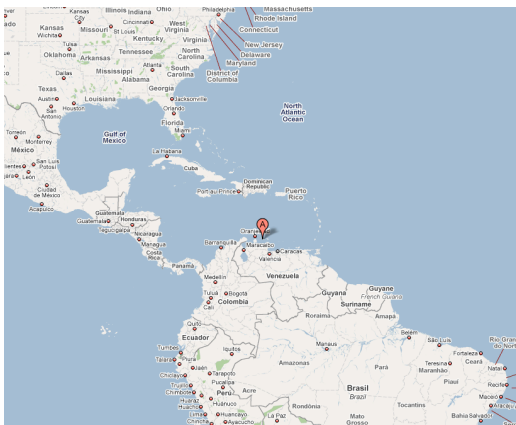

About Curacao



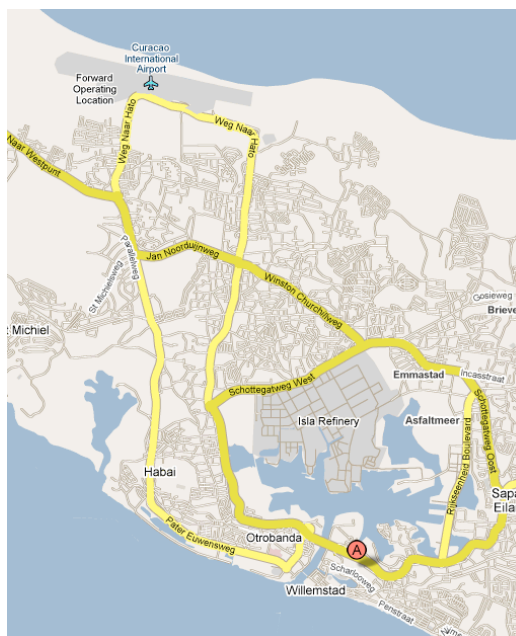
